The Dun & Bradstreet number which states the Sheriffs Office on 4th floor is a Maritime Office will be canceled- will no longer be used.

All Maritime cases being sold for county financial gain will result in arrests.

Weekly blessing over the children. On site as well as televised.

All of the people within the County will have personal access to me for a redress of grievances.

ALL concerns of the people in the County will be investigated, especially regarding public corruption.

Deputies will be educated in Constitutional law and not permitted to exercise Maritime Law against the people.

Uniforms will no longer look threatening as if going to war on the people we serve.

The jail will not hold prisoners on egregious bonds or for long periods of time, inspiring speedy trials.

Will investigate Helene cause, mishandling, and thefts against we the people, retroactively against the people beginning Day 1.

Will investigate financial matters, funding, adoptions for profit and more regarding DSS Cases. Arrests WILL occur!

FEMA Agents for Helene will be investigated for theft of goods, discarding items that would have helped the people during the disaster, and/or blocking goods from entering the County.

The war on drugs will continue and the people should live in good health and prosperity, which drugs denies them.

The Constitution and the Declaration of Independence will be prominently displayed at the Sheriffs Office for all of the people to see and posted at every entrance to every building the Sheriffs Office utilizes.

Anything that is Unconstitutional or made confusing, but utilizing Maritime Law will no longer be supported or carried out by the Sheriffs Office any longer. The Oath of Office is what I am responsible for and will be followed and revered wholly, honestly and no ambiguities will be produced by me.
